Well, for the past six years, a steadfast and committed group of Greenwood citizens has been building and growing a community foundation that connects passion with purpose. We have much to celebrate since the inception of the Greenwood County Community Foundation (GCCF) on January 1, 2011, though great opportunities for significant impact still exist.

The Foundation is uniquely situated to address issues from a variety of perspectives, such as raising awareness, convening people and organizations to address issues, and, of course, by providing grants.

In closing I would like to share with you an inspiring passage from Cleo Wade: "[t]he world will say to you, 'What are you going to do?' Do not be afraid to say, 'I know I can't do everything, but I can do something.' Walk into more rooms saying, 'I'm here to help.' Become intimate with generosity. Give what you can give, and do what you can do. Give dollars, give cents, give your time, give your love, give your heart, give your spirit."

Thank you, Greenwood, for being a generous community. We are fortunate to have people like you who are collectively working to make our city and county a better, more vibrant place for all its citizens.

Thank you for allowing the GCCF to serve, and to be a part of your charitable mission.

Early in 2106, Stephen Gilbert, Executive Director of Greenwood Community Theatre (GCT), received a vision. Not the mystical sort, but the kind that moves one to branch out in a new direction, bring others along, and persevere until it begins to take shape and effect change. Gilbert learned of a national program called The Penguin Project that opens up the experience of theatre to young people with disabilities. From that point on, he was determined to bring the Penguin Project to GCT and the Greenwood community.

After securing funding from GCCF and other sources, GCT launched their initial Penguin Project (also the first in South Carolina) in the spring of 2017. "Annie, Jr." was to be staged the following September, but first came the months-long process of publicizing this opportunity to prospective participants, and organizing information meetings and rehearsals with a director, young actors with a range of disabilities, youth mentors, adult volunteers, and production assistants.

The performance weekend of September 14-17 seemed nothing short of miraculous. In each of four shows, "Annie, Jr." played to a packed house, including community members who receive services at Burton Center. Young actors delivered every line and lyric, accompanied in the most unobtrusive way by their individual mentors. Scenes were well portrayed with humor, group numbers were lively, and the audience was on its collective feet for each curtain call.

The playbill gave biographical information on the actors, including their respective disabilities. A parent of an actor spoke to the audience before each performance to explain something of what The Penguin Project meant to their child. Young mentors dedicated months of rehearsal time to their tasks, which required them to keep a low profile on stage in order for the actor they each accompanied to shine.

Parents of actors shared words of gratitude about the lasting impact of their children's experiences months later:

"My daughter is visually impaired, has severe anxiety, ASD, and a rare genetic disorder. She has a hard time trusting people (even family) to lead her so she will not fall or trip when she cannot see well. Not only was she amazing at remembering her lines and the words to the songs, but she also didn't panic back stage where it was dark and she couldn't see - she trusted her mentors to lead her safely!"

"My older son suffers from depression. He was happy and he shined on the stage! He sang his heart out and formed connections with the mentors and other actors. My younger son has severe ADHD. He hardly shows emotions, and it took nearly the entire duration of the play, but he smiled! That may not seem like a big thing, but for a parent who rarely sees their child smile, it's indescribable."

"My child struggles with autism and anxiety and had only recently begun talking when Penguin Project started. At the very first practice, I watched my child sing and clumsily learn motions and SMILE! She loved it! Learning the songs and dances and her lines gave her confidence that I couldn't have imagined. What autism had tried to rob her of, the theater was returning to her. Since "Annie, Jr." wrapped, this confidence has translated into other areas of her life. There are no words big enough to say how grateful we are for Penguin Project."

"We decided to get our son involved in The Penguin Project because wanted him to have fun, maybe get a part, and also to make some friends. He didn't even speak until he was almost 6 years old. So when this once non-verbal autistic boy said he wanted to try out for a role, we were shocked. We didn't even know if he could sing or dance! This project brought a group of kids together and they all have found confidence, friendships, and courage! He's so happy, he walks around the house singing and dancing. And when he decided to run for homecoming court at his school last fall his campaign slogan was 'Autism is what makes me Awesome'".

Gilbert says, "I believe Penguin Project has changed Greenwood forever."Ansley Keenan directed the production and adds: "Penguin Project is so much more than producing a play. It is about relationships. Friendships. It provides a chance for parents to network and foster their own community of support. It creates confidence in kids to do things in all aspects of their lives. It is about possibilities and breaking down barriers. It is about focusing on what kids CAN accomplish instead of what they CANNOT. It is about inclusion, tolerance, and acceptance. It is about making the world a better place for our children, normalizing all abilities and people, and focusing on unity instead of differences."

We are honored to have played a role in GCT's first Penguin Project through our Community Impact grants.



One Man's Mission leads to a sustainable future for a very special summer camp

Rodney Stone was looking for a long term solution. The Greenwood CPA and member of the South Carolina Jaycees had served more years than he cared to remember as Treasurer of the organization, and he had concerns about its viability in the future. His biggest worry centered around ensuring that the SC Jaycees biggest project, Jaycee Camp Hope, remained open and continued to serve long after he, and the other Jaycees, were gone.

Established in 1969 on beautiful Lake Hartwell, Jaycee Camp Hope is a statewide residential camp for individuals with cognitive disabilities, ages 7 and up - the only camp of its kind in South Carolina for this special needs group. Made possible by a partnership between Clemson University and the South Carolina Junior Chamber of Commerce, Jaycee Camp Hope strives to give campers fun, healthy experiences in an outdoor environment during five summer sessions. While the benefits of attending are many, some of the more prominent ones include a sense of personal growth, helping campers work and play in groups, and learning to adjust socially with peers.

Stone approached the Greenwood County Community Foundation with his concerns, and his hope to create a permanent funding source for the camp. After learning about the different fund types, Rodney decided to create an endowed fund that would grow over time and provide a source of revenue that could be used as needed for facility improvements and repair. The resulting fund was named The SC Jaycees Eternal Hope Endowment.

Rodney also plans to create an additional fund for Camp Hope in 2018. Jaycee Camp Hope has provided financial support for every camper attending Jaycee Camp Hope since its inception, but Stone isn't convinced that can be sustained indefinitely. "Everything changes and if tomorrow the SC Jaycees ceased to be, I wanted to make sure our campers have access to financial assistance." This new endowment will help underwrite the costs of attending one of the camp sessions. His wish is that no one will ever be denied the opportunity to attend Camp Hope because of financial hardship. "While I'm still actively involved in the SC Jaycees, I wanted to make sure we had funding in place for the camp and for camper scholarships. I'll feel better

about handing over the reins with these two instruments in place."



The Benjamin E. MAYS endowment



Born and raised in Greenwood County, Dr. Benjamin E. Mays is a pre-eminent figure in the history of the American civil rights movement as well as one of the most notable educational leaders of African American men during his tenure as President of Morehouse College. Thirty-three years after his death, his impact is still felt within these communities.

Confidant to three U.S. Presidents and "inspirational Father" to Dr. Martin Luther King, Jr., the influence he had over thousands of young African-American men; the installation of ideals, dignity, and purpose, is evident to this day. The Greenwood County Community Foundation has formed a partnership with the Benjamin E. Mays Historic Site in Greenwood to preserve the history, and expand the extraordinary legacy, of Dr. Mays by establishing the Benjamin E. Mays Endowment.

This fund will serve two purposes. First will be the preservation, maintenance, and expansion of the Mays Historic Site as an educational and historical destination. Secondly, the endowment will house a scholarship program of national scope. The distinctive aspect of this program is that applicants will be required to demonstrate their comprehension of Dr. Mays' life and achievements. They must also be committed to his ideals of equality, excellence, and service.

Within this context, the scholarships will be awarded to students based on character, academics, leadership, and service. There are no race or gender restrictions on the scholarships, although selections in the beginning phase will be weighted toward African-American males.

Several notable contributions have already been made to fund the endowment, including gifts from the Henry and Billye Aaron Foundation, Mrs. Sally Warner (Dr. Mays' secretary and personal assistant until his death), noted historian Vernon Burton, and the late Dr. Larry A. Jackson (former Lander University President) and his wife Barbara. A broad mail campaign will begin in early 2018 to reach the endowment goal of \$5 million in 3 years.

Greenwood Women Care (GWC) is an initiative of GCCF to engage Greenwood women in collective learning, giving, and growing. The overarching goals of GWC are to offer participants the opportunity for personal growth as informed members of our community, and to improve the quality of life for everyone in Greenwood County through GWC grants. Although GWC is modeled after successful giving groups in this region, with funds held by other community foundations, a dedicated steering committee of six members has been giving shape and structure to an organization especially designed for growth and sustainability here in Greenwood County.

GWC held its first official community meeting on February 20th. Before this inaugural event, GWC already had 50 charter members. Guests were welcomed to attend along with members, consistent with GWC's mission to inform Greenwood women about needs and opportunities in our home community. Quarterly meetings will remain open to guests so that interested individuals may always visit and see if GWC membership is right for them. Each meeting will have an informal social time, as well as programs pertinent to the membership, such as pressing needs, current opportunities, nonprofit activity, etc. in our community. GWC will offer its first grants in early 2019.

GWC has the advantage of being housed at GCCF, providing 501 (c) (3) status, the ability to issue tax receipts to donors, and a permanent home. GCCF has provided substantial staff time and some material support to GWC to ensure a strong foundation. GWC is self-determining in governance and operations, will grow through membership of a broad range of women from many professional and personal sectors, and will be perpetually open to new members. While active committees are keys to GWC's success, each member can determine whether committee involvement is possible for her in any given year.

GWC's annual membership fee is fully tax-deductible. About seventy-five percent is dedicated to GWC granting funds to be awarded to nonprofits serving residents of Greenwood County, 20% to establishing the GWC endowed fund, and the remaining 10% used to cover GWC administration and operational costs.
