DIRECTOR'S NOTE



April marks the beginning of our first "Innovations" grant cycle here at the Community Foundation.

This quarterly granting focus joins Youth and Education, Community Enhancement and Open Granting (including Health and Human Services) to round out the work of our organization. This new cycle, which is our least narrowly defined, may also prove to be our most exciting.

Within our other focus area we have made some significant grants for new projects—bathrooms for Burton Center Miracle League, the on-line Greenwood History Project at the Museum and helping provide for expansion at La Puerta de Esperanza (Door of Hope). Many other grants have been made to sustain ongoing programs—some to meet those in our community with special needs and some to enrich the lives of every community resident. Grants made from our unrestricted assets have been relatively small in size, averaging less than \$3,000 each.

Our Innovation grants will be larger-and These grants will support bolder. "testing ideas that foster strategic change" originating from new sources of insight and inspiration. Thev generate collective excitement for their originality and potential as well as their courageous approach to improving and enriching the lives of the people in our community. These grants differ from our other three focus areas: no more than one or two grants per year will be funded (some years none). These grants may be considered for multi-year commitments.

I am excited about the risks, challenges, investments and community changes that will be a part of this grant cycle. The Community Foundation is here to be a part of things new and different to improve life in Greenwood County! Stay tuned for developments!

Why Would a Nonprofit **Choose to Place Their Endowment with the Community Foundation?**

Each year • this Fund will make a distribution to the club to award scholarships to top Greenwood County students. - An "Agency Fund" allows the nonprofit to focus on its mission. Time to manage an in-house endowment may not add up to the return since administration, audit and tax filing costs of a separate organization-related foundation can be high.
- The Fund is invested in a larger pool of assets, which can lead to greater growth, greater income, and lower investment fees.
- The Foundation can help in establishing, marketing and growing the endowment through bequests or alternative asset gifts.
- A Fund provides permanent protection from possible future Board neglect, shortsighted

- invasion, or improper use-GCCF serves as the guardian of the Fund.
- Creation of a Fund assures donors their conditions are perpetually met— if the organization should cease to exist, it is GCCF's responsibility to use the Fund, in as much as possible, to comply with the donor's original intent.

And here is another very tangible bonus: Greenwood County Community Foundation is currently matching fifty cents on the dollar all endowed gifts, meaning you can start an endowed Fund with only \$14,000, which immediately becomes \$21,000. If you are related to a local nonprofit, please consider an endowment at the Foundation to establish a permanent and predictable source of income for the organization.

instruction and life skills lessons to prepare people for gainful employment that will lead them towards selfsufficiency. The program is offered free of charge to those in need. The students develop their skills by cooking meals for the Feeding Hungry Children Project."

Another Donor-Advised Fundholder has enjoyed



several trips to the Florida Keys and has grown to appreciate the natural beauty and diverse wildlife of the area. Hidden Harbor Marine Environmental Project opened the Turtle Hospital in 1986 to rescue, rehab and release tropical sea turtles.

A variety of ailments are treated including flipper amputations caused by fishing line and trap rope entanglements, shell damage caused by boat collisions, and intestinal impactions caused by ingestion of foreign materials such as plastic bags, fishing line and/or hooks.

The Turtle Hospital has successfully treated and released over 1000 Sea Turtles since its founding.



Appreciated Asset Gifts – Double the tax benefits, twice the fun

Creating your own Fund at the Community Foundation with an appreciated asset, such as stock or real property, has multiple advantages. The stock market has broken records this year, with the Dow regularly above 14,000, so you may be holding an asset that could be used to make your charitable dream come true.

Due to an uncertain tax climate and several years of strong markets, 2012 was a record year for "donor advised" charitable gift funds (DAFs). DAFs enable charitably-minded

taxpayers to contribute money in one year and reap a tax deduction then, while postponing decisions about donations to specific causes into the future. Once in the account, the money is invested and grows tax-free, enabling the donor to give more over time. However, gifts may be made quickly when the donor is ready.

A Donor-advised Fund can also facilitate distribution from the contribution of a large, indivisible appreciated property such as real estate. Property can be contributed to a DAF, sold without tax consequences, and the proceeds used to make smaller contributions to multiple recipients or donations over time.

While deducting the charitable gift at market value in most cases, donors receive another tax benefit when they donate appreciated property, because they do not have to pay capital gains tax on the appreciation. For this reason, many choose to make gifts from their IRAs or retirement accounts—where long-held investments may include one's most highly appreciated assets.

Remember that a Donor-advised Fund at the Greenwood County Community Foundation can be established for as little as \$14,000. Appreciated stock or real property may be just the gift to start your own Fund and reap the benefits. Call us for more information about why this solution might work best for you.
