





Grant Cycles and Grant Review Committees

There are currently four annual grant cycles at GCCF: Youth and Education, Innovation, Community Enhancement, and Open Granting, Unrestricted Funds enabled the Foundation to award grants totaling more than \$75,000 in 2015. Grant Review Committees for each cycle are made up of Greenwood County community leaders who carefully review and evaluate grant applications and make funding recommendations to the GCCF Board of Directors. Each applicant organization seeks to enrich the Greenwood community.

Granting has been a priority from the beginning. Board Secretary Sam Leaman recalled, "The founding Board of the Foundation was advised to make grants as soon as possible. When we did, beginning in 2012, it felt like the Foundation had instantly become relevant to our community. We knew we would be able to continue to help other non-profits through this

The Foundation's Board of Directors bears fiduciary responsibility for the assets of the organization. They have again selected two investment managers to facilitate their work: Park Sterling Investment Services in Greenwood and Wealth Management Services of UBS in Greenville. The Investment Committee and Board feel this represents a good balance of "keeping funds local" while utilizing the expertise of UBS' Greenville-based institutional investment team for the entire southeastern United States. This year the investments of the Foundation had a loss of -2.8% net of fees for 2015, which reflected overall market performance, but outperformed respective indices. The investment allocation is shown on the adjacent pie chart.

Community Indicators Project

2015 was the second year of the Community Indicators Project (CIP), where results of the first year's needs assessments were evaluated and next steps, including securing the right candidate for the Coordinator's position, were initiated. GRANT HIGHLIGHT

Collaboration Takes Hold: "Show Your Strength Greenwood"

Cathy Miller and Alice Hodges, Executive Directors of Beyond Abuse and Meg's House, respectively, teamed up to seek funding in last spring's Youth & Education Grants cycle. Each agency addresses aspects of domestic violence, sexual assault, and child abuse, and both Directors saw a unique collaboration opportunity: to raise awareness among men in the Greenwood community about abuse and to engage them in its prevention while seeking solutions for abuse. In applying for the grant, Hodges and Miller stated, "This crosses all socio-economic backgrounds.

There is a strong correlation between domestic violence and child abuse. Over 90% of victimization is orchestrated by men. Our program will engage men in prevention and eradication."

In 2015, averages of 50 men attended each of three quarterly "Show Your Strength Greenwood" events, held at St. Mark United Methodist Church fellowship hall. (An additional event is slated for March 2016.) At these sessions attendees learned about a focus topic and heard knowledgeable guest speakers, including Dr. Tony Jones (Director of Project Unity USA, NC), Solicitor David Stumbo, and WYFF Channel 4's Michael Cogdill. Many signed pledges to "never to commit, condone or remain silent about violence against women and children... to learn how I can help to end violence against women and children...[and] to work toward creating a community where all people are valued and safe."

Hodges and Miller are working to create an active forum for Greenwood men to share news, ideas, and information to inspire other men to become advocates to end domestic violence and sexual assault. Miller reports, "The collaboration between Beyond Abuse and Meg's House on this program was a natural fit. Greenwood County ranks 1st in the state in Domestic Violence and 11th in the state for Sexual Violence. We are counting on the good men in Greenwood County to learn more about violence against women and children and to help us end it by being advocates for change." Hodges comments, "I am excited about 'Show Your Strength Greenwood' and the fact that men in our community want to be engaged to stop domestic violence and sexual assault. It is important that men exhibit positive leadership. to eradicate domestic violence, sexual assault, and child abuse. We are fortunate to have the financial support from Greenwood County Community Foundation for this important project."

FUND FOCUS

Jaycees Eternal Hope Endowmnent

Rodney Stone has been thinking about the future

for some time now. As Treasurer for the S.C. Jaycee Foundation, one of his main areas of focus is Jaycee Camp Hope at the Clemson University Outdoor Lab in Pendleton, S.C. This unique facility offers mentally handicapped individuals ages 7 and older an opportunity to enjoy fun, challenging and educational group activities in an exciting setting designed to develop independence by teaching campers how to do activities for themselves. The S.C. Junior Chamber of Commerce has provided financial support for every camper attending Jaycee Camp Hope since 1969. To date, the Jaycees have subsidized more than 10,000 camper's attendance at a cost in excess of \$950,000. The Jaycees were also instrumental in establishing the Outdoor Lab as a permanent home for Jaycee Camp Hope in 1975. For many of those years Rodney Stone has been the hub of all of that financial activity. "I've been involved with Jaycee Camp Hope for many years as the Treasurer of the S.C. Jaycee Foundation, and I've witnessed firsthand the positive impact that an outdoor experience can have on mentally handicapped individuals," Stone said. "I wanted to ensure that, for generations to come, similarly challenged adults and children would continue to have that same opportunity through camp scholarships and the best facilities in our region." To make that desire a reality, Stone and the S.C. Jaycee Foundation Board of Directors created the S.C. Jaycees Eternal Hope Endowment at GCCF. As this fund continues to grow, mentally handicapped children and adults will continue to receive scholarship funding to Jaycee Camp Hope. Additionally, funds can be allocated for capital improvements and facility upgrades as they are available. As he looks towards the future, Stone can strike one item off of his "to do" list. "This fund will make sure those camping experiences are available long after I and the current Board and staff members are no longer involved, and that the camp is as up-to-date as possible."
