

Church, Patrick is active in the community, and currently serves on the Board of the Upper Savannah Land Trust in addition to his service with GCCF. Patrick is a former Board Chair of the Greenwood Arts Council and his church Diaconate, and is also a Paul Harris Fellow through the Rotary Club of Greenwood.



In addition, GCCF announced that in 2021 three Board members will assume new roles. **Trentsie Williams** will serve as Board Treasurer, replacing Boo Ramage. **Dr. Gay McHugh** will serve as Secretary, replacing Martha Barnette. **Wells Dunlap** will fill the At-Large seat on the Board's Executive Committee recently held by Ms. Williams. Ms. Williams currently serves as Director of Finance at MEG's House; Dr. McHugh is a recently retired educator and administrator in Greenwood School District 50; Mr. Dunlap is a Commercial Relationship Manager and Vice President with Countybank. "I am very excited to have such a high caliber Board of Directors," remarked Smith. "Our Board consists of charitable, community-minded individuals who want to help make Greenwood the best it can be for everyone."

## President's Message

**2020.** I could probably stop right there and you would assume a number of scenarios concerning the Community Foundation. Yes, the Foundation was overwhelmed by the same Covid tsunami as every other business. Yes, we struggled to regain our bearings and navigate a vastly altered landscape. And yes, we worried that we would be dramatically impacted by the shutdown of our community.

But we continued to open our doors and conduct business (somewhat) as usual, and began partnering with other organizations to assist others in the community. Along with the Self Family Foundation and Greenwood Mills, we purchased and made available face coverings that were distributed free of charge, initially at the Greenwood Development offices, and later at the Chamber of Commerce office. We maintained communication with our state and regional counterparts to learn about efforts being made elsewhere to assist those in need, and we continued to connect with our local nonprofit community to receive updates on their work and to determine the greatest areas of need.

Greenwood County Community Foundation maintained our regular schedule of Community Impact granting, and the wonderful philanthropists for whom we hold donor advised funds answered the call and made gifts that provided critical funding to assist those facing eviction due to imposed quarantines and inability to work. In total, \$555,335 in grants were made in 2020; the second-highest total in our history.

As we adjusted to the restrictions placed upon us by the pandemic, another remarkable thing occurred. Individuals stepped forward to create new charitable giving funds – five new funds in 2020. Not a record by any means, but impressive given the atmosphere in which we were operating.

By and large people are good and care about their neighbors and fellow citizens. When it really mattered, Greenwood stepped up and came to the aid of those in need. The Community Foundation is proud to have been a part of that effort and is committed to continuing – and expanding – our mission to serve our community, and to help individuals, families, and nonprofit organizations maximize their own philanthropic visions.

## Preserving History, Honoring an Educator

A small group of dedicated Brewer High School alumni realized the fulfillment of a major goal, years in the making, when they created the "Benjamin J. Sanders Jr. Scholarship Fund," named for a revered long-time educator and administrator at Brewer High School.

The scholarship, which was funded by proceeds from the Benjamin J. Sanders Jr. Trust Fund and is held by the Greenwood County Community Foundation (GCCF), will provide selected high school seniors of African American descent a one-time gift to be applied to their first semester tuition at a two- or four-year institution of higher learning. Seniors in all three Greenwood County districts who are on track to graduate will be eligible to apply.

Recipients will be selected by a committee comprised of members of the scholarship committee and community leaders. Gifts will be awarded based on availability of funds and successfully completed applications. Guidance counselors at all four high schools will be provided application materials and scholarship criteria. The first scholarships are scheduled to be awarded in the spring of 2021.

Through their membership contributions and other gifts to the GWC Granting Fund, GWC awarded \$74,000 total to 10 local nonprofit organizations in their 2020 grant cycle.

# Greenwood Women Care Keeps the Light Burning

What a year strange and splendid year 2020 was!

In January, we danced the Salsa and shared conversations with Members and guests over Venezuelan fare at The Venezuelan Spot. In early February, our Membership Committee welcomed 24 new Members with homemade soups, salads, breads, and desserts and camaraderie in a Member's home, bringing our membership to 129. Later in February, we gathered at the Harley Family Center to socialize and to learn about the missions of Burton Center and Greenwood Place as they serve community members with special needs.

We could not have known then that the remainder of 2020 would pass without our being able to safely meet in person again. Who among us had heard of Zoom in early March of 2020? Yet, by the time of our August Quarterly Meeting with its virtual tour of the Benjamin E. Mays Historic Site, zooming was a still new, but already well-established verb in our collective vocabulary.

Like many around Greenwood and in the larger world, we wondered how long we should "wait it out" before planning another in-person meeting. In the meantime, how could we continue to inform our Members about needs and opportunities in our community? The solution: Nonprofit video snapshots! A call went out to Greenwood County nonprofits with an offer to feature local organizations in individual video snapshots. Twenty-three responded and the videos were shared by email with our Members and guest contacts, participating organizations, and on our webpage and Facebook page.

Members of our Grants Review & Awards Committee conducted GWC's Grant Writing 101 workshop virtually and at no charge to the 30 participants from local nonprofits. In November, we learned about "Lighting the Way with Literacy" in our Quarterly Meeting arranged by the Programs & Education Committee and featuring literacy programs at Community Initiatives and the Greenwood County Library. The Governance & Finance Committee met numerous times to revise our already outdated GWC Guidelines into a refined Governing Document. Our Communications Committee stayed in touch with Members by sending birthday cards and the Social Committee delivered specially commissioned GWC candles on each Member's doorstep.

But the highlight of 2020 was the annual culmination of GWC's carefully constructed granting process that includes ranked voting by our Members. In October, GWC awarded \$74,000 to 10 nonprofits serving Greenwood County and enriching our common life in a variety of ways. Awards ranged from \$2000 to \$10,000.

GWC looks forward to 2021 as another year to learn, give, and grow!



## 2020 Community Impact Grants

#### YOUTH & EDUCATION

GCCF Community Impact Grants are awarded annually in three, regular cycles. Grant Applicants may request up to \$5000 in funding for a program or project serving residents of Greenwood County. In 2020, GCCF awarded funding to a total of 24 Nonprofit organizations, including five receiving GCCF funding for the first time. In this most challenging year, GCCF Community Impact grant recipients found effective ways to continue to carry out their missions.

Three of our 2020 grant recipients are featured here.

Boys & Girls Clubs of the Lakelands seeks to serve the children and youth in our community most in need of their facilities and programming. When the pandemic struck, these needs were heightened. With the closing of schools and the resulting lack of access to Wi-Fi, school lunches, and daily interaction with caring teachers, Boys & Girls Clubs opened supervised virtual learning and afterschool programs to help students navigate learning platforms, resume some sense of normalcy, and allow working parents to continue to do their jobs.

With their GCCF grant, this organization was able to purchase much need personal protection equipment such as masks, shields, and hand sanitizers as well as thermometers and extra supplies to ensure that our staff and students would remain safe in these turbulent times. Sabrina Miller, Executive Director, noted, "This grant allowed Boys & Girls Clubs staff and volunteers to spring into action quickly and be fully ready to receive students when the families we serve needed us most".

#### **COMMUNITY ENHANCEMENT**

GCCF awarded a Community Enhancement Grant to Greenwood Area Habitat for Humanity for the purchase of materials and the payment of subcontractors for a new home build scheduled to begin later in the spring of 2021. The home will be constructed in the Westside neighborhood of the City of Greenwood, where Greenwood Area Habitat is planning a development of 18 homes to be located between Mineral and Carolina Avenues, and where GCCF helped to make possible a home build on Neel Street in 2019.

Through its Homeownership program, Greenwood Area Habitat for Humanity provides the land, materials, and expertise to help families build their own homes alongside volunteers. An affordable mortgage is then arranged so that the families can achieve financial stability and independence. No profit is sought; the homebuyer repays only the cost of building without fees or interest.

"During the COVID-19 crisis, we have been reminded how important it is for every family to have a safe place to live," said Greenwood Area Habitat Executive Director Stephen Baggett. "The support of the Greenwood County Community Foundation will help the members of a local family change their lives forever, and for that we are grateful."

#### **OPEN GRANTING**

Greater Greenwood United Ministry (GGUM) Crisis Ministry received a GCCF grant in December to assist families facing rent eviction. There were 12 families served through this grant. The approved amount for assistance was sent directly to the family's lessor to prevent eviction.

Individual assisted by GGUM participate in personal interviews. Often individuals are being evicted because they have had a life crisis or emergency. These crises include, but are not limited to, divorce, job loss, health issues, and effects of COVID-19. GGUM strives to assist an individual through their life crisis and give them intervention steps to guide them away from a state of chronic crisis to a state of self-sufficiency, making recommendations for other community resources as needed

Rosemary Bell, Executive Director, shared the following story of assistance made possible by this grant award: "A gentleman came to the Ministry with his two very young daughters with him. He said that he needed assistance with his rent eviction. As his story slowly unfolded in the interview, we learned that although he and his wife were employed, his family had been affected by injury, prolonged rehabilitation, and childcare issues. He received rent eviction assistance but declined GGUM's offer of food. He wanted to leave the bag for someone else who needed it more than he did."

At the same time, Steve Riley, owner of Emerald Ink and Stitches had created the #teamgreenwood concept where people could buy a t-shirt emblazoned with the hashtag, and the proceeds from each sale would go to area restaurant workers to help make up for lost tips and wages. Clay piggybacked on that concept with a series of nightly live streamed concerts featuring area musicians. The "Until Further Notice" series of virtual concerts raised awareness of the #teamgreenwood project with artists encouraging people to go to their favorite restaur ants, buy t-shirts, and support the staff. Artists who depend on performing live for their income were also invited to use their live stream shows to seek donations either for themselves or to assist other charitable efforts. Sprouse was also a concept partner in the very successful viral remake of Don McClean's "American Pie" single that also featured numerous local artists putting their unique spin on one of the country's most enduring rock anthems.

Because of his ingenuity and initiative, the Greenwood County Community Foundation felt that Clay Sprouse was deserving of its first "Community Hero" honor. "Clay represents what is so good about our community," said GCCF President Jeff Smith. "People pull together and support one another. This is a classic example of that support."

**Tommy** "Tommy Claus" Tumblin Making **Christmas Brighter** for Children In Need

Tommy "Tommy Claus" Tumblin, long time Lander University employee and the catalyst behind one of Greenwood County's most successful Christmas toy drives, stepped away from the philanthropic campaign he shepherded for so many years to focus on family issues. In honor of his selfless devotion to the underserved children of Greenwood County, The GCCF bestowed Tumblin with its prestigious Community Hero award on November 20th in recognition of his service as "Tommy Claus."

Tumblin, who has distributed toys to thousands of children in the Upstate for 20 years, began in his garage and eventually had to move to a warehouse belonging to Joel's Floor Coverings in Greenwood. He made the difficult decision to retire the program because he needed more time to care for his ailing father, Bud Tumblin.

Tumblin's philanthropy was lauded by both Smith and Dr. Leary during an impromptu surprise presentation at Lander. An emotional Tumblin was surrounded by his peers from Lander's Physical Plant as well as other University friends as Leary expressed his gratitude. "We are so grateful for you. This award is a small token of appreciation from the entire Greenwood community."







## Foundation Receives Funds **Upon Retirement of Two Greenwood Nonprofit Legends**

2020 ushered the end of two significant eras with the retirements of The Self Family Foundation's President, Frank J. Wideman III, and The Arts Center of Greenwood's Executive Director, Anne Craig.

Wideman was honored for his 27 year career with the Foundation during a June 30 reception in the Calhoun Mays Reception Hall in the Arts Center. During the ceremony, Jay Self, Chairman of the foundation's Board of Trustees, thanked Frank for his dedication to the Foundation and the community, and presented a check in the amount of \$27,000 to Jeff Smith, president of the Greenwood County Community Foundation, to establish a donor advised fund in Frank's honor. Jay stated that "this fund will allow Frank to continue to support the organizations he feels strongly about in his retirement."

Senator Floyd Nicholson presented Wideman a resolution on behalf of the South Carolina Senate, thanking him for his commitment and service to the foundation, the Greenwood community and the state of South Carolina.

On October 29th, Craig was recognized for her service to the arts community of Greenwood over a 23 year career that started in a small office on Waller Avenue, and led to the fulfillment of her vision of renovating the old Federal Building into gallery and studio spaces, bringing in traveling art exhibits as well as recognizing local artists and conducting summer arts camps for children.

During her reception, Anne was informed that a gift in the amount of \$23,000 was being made to the Arts Center of Greenwood's endowment held at the Greenwood County Community Foundation. This fund was established to further the mission of the Arts Center to raise awareness of, and exposure to, the arts in Greenwood County.





## GCCF's Community Response Fund Gets Early Test

In 2015, the Greenwood County Community Foundation's Board of Directors decided to set aside a monetary reserve earmarked to assist responding agencies in times of disaster. That "Disaster Fund" was quickly depleted later that year when the Upstate experienced what was labelled a 1,000 year flood and the Red Cross needed financial assistance to better assist Greenwood residents impacted by the overflowing rivers and creeks, and breached dams.

The fund sat empty after that for several years, but was revived in 2018 with the same mission, but with a different name and structure. "I was never a fan of the name 'Disaster Fund,'" said GCCF President Jeff Smith. "It didn't seem to encompass what I envisioned the fund to be, which was broader in scope than just natural disasters." The re-imagined fund, renamed the "Community Response Fund," (CRF) would also include corporate partners in the community who would commit to helping to build a sizable fund through which grant assistance could be made to responding agencies in the event of not only natural disasters, but other large scale occurrences that negatively impact segments of Greenwood County's population. In 2019, the Community Foundation partnered with the Greenwood County Emergency Management Department to reinvigorate the fund.

2020 provided an opportunity to test drive the CRF with the Covid-19 pandemic and subsequent shutdown. Again, with little available funds, the Community Foundation partnered with the Self Family Foundation to purchase and distribute facemasks and other personal protection equipment for area nonprofit agencies. Also, through the generosity of a number of fundholders, GCCF provided financial assistance to local nonprofit agency Community Initiatives which was working to assist individuals facing mounting past due rent or power cut-offs due to quarantine restrictions and the inability to work.

As GCCF prepares to once again build the Response Fund, community partners will be sought to make it a major resource in times of trouble and need.
