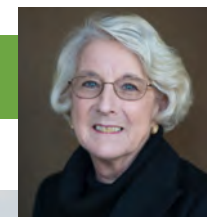

ANONYMOUS BEQUEST TO BENEFIT LOCAL HOSPICE ORGANIZATION

Greenwood's Hospice and Palliative Care of the Piedmont will have the ability to provide a much higher quality of care to those families who find themselves in need of their services due to the generosity of an anonymous donor who left almost the entirety of an estate to be used to support the nonprofit's work in Greenwood County. This major gift, *given in appreciation of the care a loved one received at Hospice House*, was set up as an endowed designated fund at the Greenwood County Community Foundation (GCCF) to provide annual operating revenue above and beyond that which is generated through gifts, fund raising efforts and proceeds from their resale store. According to Hospice and Palliative Care CEO Charlene Kish, this gift will allow her organization to increase and improve services, but it will not remove the need for continued contributions from the public. *"It is rare to have this type of facility in a community as small as ours due to the high cost of providing the service and inadequate reimbursement."* Today, the organization must have significant donations to cover the losses in the Hospice House and perpetuate the standards of excellence that our community has come to expect. This endowment will help ensure that the same care their loved one received will be there for anyone who needs it. Also, these endowed funds will provide the organization with resources to be able care for more chronically and terminally ill individuals and their families and friends in our community. We are humbled and grateful for the generosity of this donor."

In addition to benefitting Hospice and Palliative Care of the Piedmont, this gift was sizable enough that it essentially doubled the assets held by the Community Foundation, which will also provide GCCF with resources that can be used for a number of purposes. "We are delighted that Hospice and Palliative Care of the Piedmont will benefit for years to come due to the generosity of this anonymous donor," said GCCF President Jeff Smith. "But the Foundation will be positively impacted as well, as the administration of this gift will allow us to expand our services and increase our impact on Greenwood's nonprofit community."

YOUTH & EDUCATION

GCCF awarded a grant to Next Level Lifestyles for development and expansion of their career and job mentoring program. Next Level engages more than 200 youth, ages 8-25 in classes, fitness experiences, nutrition and community service, and maintains a full gym. Academic support is also offered on site.

Titus Williams, Executive Director, noted: "Realizing that our services exceed physical activity (of the previous organization, Next Level Fitness) and also provide youth with mentorship, academic assistance, community service projects, wellness and nutrition, we decided that Next Level Lifestyles embodies the wholistic approach we take in changing the lifestyles of some of Greenwood's most vulnerable youth. Our goal is to continue providing quality programs and maximizing our organization's actions by following our mission of 'providing service and positive influence on the youth of our community through athletics, physical fitness and mentorship.' What we hope to accomplish through our venture is to not only provide youth with a safe place where they can find comfort away from the troubles of their communities, but where they can gain valuable lessons along the lines of work force and post-graduation. We want to make such a positive impact on the youth in our program that they change the environments in which they live. We want to mentor them so that they become mentors."

OPEN GRANTING

The Greenwood Cancer Fund received a grant to support their services to individuals with a cancer diagnosis. The Fund assists with purchasing cancer-related medications, medical and/or nutritional supplies, obtaining medical equipment, and transportation.

Stefanie Bowen, Greenwood Cancer Fund Coordinator shared: "The grant awarded to us from the Greenwood County Community Foundation will help us to pay for the prescription medicine for the patients that we otherwise may not have been able to help. This gift also has a positive economic impact on the Greenwood community as well! We use local vendors to purchase our supplies so any money we receive is recycled into the Greenwood economy therefore sharing the generosity of this wonderful organization with the entire community of Greenwood. Thanks to the grant given to us by Greenwood County Community Foundation we can give more people in Greenwood hope in their battle against cancer."

Excellent nonprofit organizations carry out their missions of serving and enriching our community day after day, year after year. GCCF is pleased to support these efforts with grants to assist in sustaining or bringing their projects and programs to life.

COMMUNITY
ENHANCEMENT

Tranquility Point is a new nonprofit aiming to serve military service members and veterans suffering from PTSD, “at-risk” groups including foster children and families, community first responders and veterans in need of personal assistance identifying and connecting with local resources.

Tranquility Point was founded by Barry Gambrell and Kim Kueker-Gambrell and is located on lakefront property on Lake Greenwood. GCCF awarded funding for materials for a handicap access ramp and pathway to a cabin, greenhouse, and main drive entrance on the site. The ramp will serve to make all these facilities more accessible to individuals and groups.

The Gambrells reported: “This ramp allows us to reach out to our community’s assisted living and retirement centers and get them out to participate in the holistic activities we offer to help combat depression and anxiety. It will also serve younger foster children and service animals. Veterans from AMVETS of Abbeville donated more than 128 man-hours or an equivalent labor cost of \$2,560 to complete this project. These few days gave them the opportunity for camaraderie and sharing their military experiences. For some it was a form of therapy. It meant a lot to them to be able to help other veterans struggling with the hardships that come with reintegrating back into civilization and the scars of combat.”

In 2022 the Greenwood County Community Foundation provided educational financial assistance to eleven Greenwood County high school seniors who would be continuing their educations after graduation. This represents the largest number of awards the foundation has made in one year from scholarship and other funds it holds. CARING WOMEN BUILDING COMMUNITY

Greenwood Women Care (GWC) was established as an initiative of GCCF in 2017. GWC is an open membership organization that invites all community-minded women to join in collective grantmaking.

Our open membership is only one distinction of this organization; we also welcome guests to come to as many meetings as they would like, and even to bring their own guests along. A woman need not wait for an invitation to join GWC – all interested women already invited! We present programs that feature those engaged in excellent work in our community to inform us about local needs and opportunities. Our Quarterly Meetings and Annual Meeting include a social reception, and two Socials each year are devoted solely to enjoying each other's company in a relaxing setting. We identify a range of hosting venues to further acquaint members and guests with community entities and have been wonderfully hosted by more than 20 of these. Our ages cover a range of more than six decades and we come from an array of life and work experiences.

In the fall of 2022, GWC reached a significant milestone: we made GWC Grants in our fourth granting cycle that brought our total grants to 41 and total awards to \$256,800! Over a quarter of a million dollars moved into our community to support worthy nonprofits from the collective, annual contributions of GWC members in only five years of existence! We end 2022 grateful for each of our members' contributions in 2018-2022 and for the support of others in our community as well.

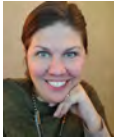

THE APPLAUDING POSITIVE ENERGY IN MEMORY OF MICHAEL E. "MONKEY" CRAWFORD SCHOLARSHIP (SCHOLARSHIP)

Created by his wife, Pat, this scholarship to honor Michael "Monkey" Crawford will be available for graduating seniors of Ware Shoals High School who will continue their education at a 2- or 4-year institution of higher learning.
